Ronald McDonald House Charities' of Kentuckiana's mission is to provide a home away from home for families of children receiving healthcare in area medical facilities, while also lending aid to other organizations that serve children.

In 2008, Ronald McDonald House provided a home away from home for 1,700 families and 4,558 family members of seriously ill children. In addition to providing a place to sleep in one of our 29 guestrooms, we offered families laundry facilities, meals prepared by volunteers, and more. The average stay at Ronald McDonald House was 5.5 days, and 391 families stayed one week or longer.

Ronald McDonald House Charities of Kentuckiana is committed to supporting local organizations that serve children through its grantmaking program, and it also supports higher education by providing scholarships to college students. In 2008, thirteen organizations received over \$80,000 in grants, and seven incoming college students each received \$3,000 scholarships.

Our Ronald McDonald Family Rooms take the concept of a freestanding Ronald McDonald House, then move it inside the hospital. In 2008, Ronald McDonald House Charities of Kentuckiana operated three Ronald McDonald Family Rooms. Over 500 families were provided with a home away from home inside Kosair Children's Hospital, Norton Suburban Hospital and Frazier Rehab Institute.
